As per the Companies (Registered Valuers and Valuation) Rules, 2017, an individual may become Member of any Registered Valuer Organisation (RVO) of Insolvency & Bankruptcy Board of India (IBBI), if he is eligible to become Valuer.

For this purpose, IOV-RVF enroll the individuals as Primary members after scrutinizing and establishing their eligibility to become Registered Valuers. Thus the primary members become part of enrolment register of IOV-RVF.

IOV-RVF always suggest and request its primary members to give IBBI examination and become Registered Valuer as soon as possible on completion of 50 hours training to ensure their seamless transition to become registered valuers under the impending Valuers Act.

IOV Registered Valuers Foundation, being the member centric organisation also provides following benefits to its primary members on complimentary basis: -

- 1. 50 Hours Participation certificate to take IBBI examination;
- 2. IOV-RVF membership certificate;
