NOTICE INVITING TENDER

The Chief General Manager (H&C), APGCL invites sealed tender from the eligible Govt Approved valuer to carry out Valuation of movable & immovable assets of the following power project under APGCL;

1. Bordikorai Small Hydro Electric Project (4.7 MW)
Location 1 : Itakhola, Biswanath District, Assam
Location 2 : BKV Investigation Division Store, Jagiroad, Assam

Eligibility of Bidders: The bidder should be a Govt. registered valuer with experience in value assessment of assets of Govt. /PSU Organizations.

The Interested bidders having eligibility are requested to submit their offer for the aforesaid job furnishing the following information.

1. Govt. registered licence number with validity supported by self attested photocopy of the licence.
2. Experience credentials with supporting documents
3. Maximum value of the asset evaluated in a single job during the last 5 (Five) years.
4. Rates for valuation inclusive of applicable taxes. Rates should be mentioned both in numericals and words.
5. Terms & conditions such as,
 - a) Data to be made available from APGCL
 - b) Any others
6. Full postal address of the office/ establishment of the bidder.
7. Income Tax Clearance Certificate for the last three years.
8. Self attested Photocopy of PAN Card
9. Self attested photocopy of GST registration. GST No. should be active.

Detail list of the important plant and machineries & vital civil structures to be evaluated can be collected from the o/o the Chief General Manager (H&C), APGCL within office hour (preferably within 10:00 am to 4.00 pm) up to 28.08.2023. Interested bidders shall be allowed to visit both the locations of the assets for physical inspection after obtaining prior written permission from the undersigned.

Time of Completion: The entire evaluation work should be completed with submission of final report within 45 (forty five) days from issue of the LOI/Work order. The evaluation of each selected items should be on depreciated value as well as on Residual Income valuation (RIV). The selected bidder shall have to enter into a contract agreement with APGCL for successful completion of the job.

The interested bidders having requisite qualification should submit all requisite documents with their offer in hard copy in a sealed envelope addressed to "The Chief General Manager (H&C), APGCL, 3rd floor, Bijulee Bhawan, Paltanbazar, Guwahati-01" within 1.00 PM of 30 Aug 2023. The bids will be opened on the same date at 3:00 pm. The bidders or his authorized representatives may be present at the time of opening.

The selected bidder may be called for further clarification and negotiation before placement of the order.
